Any terms or conditions proposed in Seller's acceptance of the Order which are different from the terms and conditions herein are hereby rejected and shall not be construed to be a part of the Order. Any reference in the Order to Seller's proposal shall not include any terms and conditions attached to such proposal or referred to therein. This Buyer upon Seller's delivery of such Products to designated carrier in Agreement may not be amended, changed or modified except by a writing signed by Buyer and Seller. Buyer shall be liable for the payment only of those sales Products specified in the Order, less payments already made. Upon taxes, if any, which Seller is required by law to collect from Buyer.
